TERPACIS INDIGENES CMM CONSIDER RESTORATION TO PRE DASH EVACUATION STANDARDS IS INESCAPABLE MORAL RESPONSIBILITY BOTH AEC AND DOD UNDER WHOSE DIRECTION AND AUTHORITY CASTLE OPERATION IS BEING CONDUCTED PD PARA FOUR PD IT IS RECOGNIZED THAT ATOLLS AND INHABITANTS ARE UNDER JURISDICTION HICOM TERPACIS AND MR DOD OR AEC CMM BUT IN VIEW HICOM TERPACIS LACK OF RESOURCES FOR THIS TASK AND MORAL RESPONSIBILITY OF DOD AND AEC CMM IT BEHOOVES CJTF SEVEN CMM AS AEC DASH DOD AGENT CMM AND CINCPAC CMM AS DOD AGENT TO MAKE NECESSARY ARRANGEMENTS WITHIN THEIR RESPECTIVE CAPABILITIES TO RESTORE ATOLLS TO PRE DASH EVACUATION STANDARDS AND TO RETURN NATIVES AT APPROPRIATE TIME PD THEREFORE PROPOSE CONCLUSION THIS MATTER BY USE PERS AND SERVICES FROM INTERESTED COMMANDS AND COGNIZANT AGENCIES FOR PURPOSES INDICATED CLN ABLE PD TRANS FOR NATIVE RETURN FROM PACFLT OR JTF SEVEN FORCES DEPENDENT UPON DATE SUCH ACTION PRACTICABLE PD BAKER PD HEALTH AND RADSAFE MATTERS FROM JTF SEVEN AND AEC PD KWAJALEIN FACILITIES AS REQUIRED PD CHARLIE PD DECONTAMINATION OR ASSOCIATED RECONSTRUCTION FROM JTF SEVEN AND PACIFIC PROVING GROUND AEC CONTRACTOR PD DOD PD PROCUREMENT REPLACEMENT LIVESTOCK BY HICOM TERPACIS PD INFORMED HICOM TERPACIS HAS INITIATED PROCUREMENT AND WILL REQUIRE ASSISTANCE JTF SEVEN CMM PACFLT AND POSSIBLY NSTS IN ARRANGING TRANS PD EASY PD CINCPAC WILL ENSURE COOPERATION ALL PARTICIPANTS FOR CONCLUSION PROJECT PD THIS HOWEVER ASSUMES NO RPT TO RESPONSIBILITY FOR CONTINUED MEDICAL OBSERVATION OF NATIVES AND ATTENDANT RADIOLOGICAL STUDIES PD PARA FIVE PD MY VIEW IS CLN ABLE PD CINCPAC SHOULD BE ASSIGNED RESPONSIBILITY FOR THIS MATTER WITH AEC ASSISTANCE PD BAKER PD CJTF SEVEN SHOULD BE DIRECTED TO REPORT TO CINCPAC FOR CARRYING OUT APPROPRIATE TASKS UNTIL HIS DEPARTURE FROM AREA CMM THEREAFTER LEAVING SUCH PERS AS FOR PROJECT COMPLETION AND ALLOCATION FUNDS TO DEFER AN NORMAL SERVICE SUPPORT PD PARA SIX REQUEST AND CLEARANCE WITH APPROPRIATE GOVERNMENT AGENCIES
