REFERENCE YOUR DTG 200025Z CONCERNING MEDICAL RESURVEY AT RONGELAP. THE DIVISION OF BIOLOGY AND MEDICINE AND THE MEDICAL DEPARTMENT OF BROOKHAVEN NATIONAL LABORATORY HAVE REEXAMINED THE ADVISABILITY OF RESURVEYING THE WHOLE BODY CONTAMINATION BURDENS OF THE MARSHALLESE DURING MAY. ALL CONCERNED BELIEVE THAT THE PROMPTEST RESURVEY POSSIBLE IS IN BEST INTERESTS OF AEC, STATE, INTERIOR, AND DOD. THE POSSIBLE CHANGES INDUCED IN THE ENVIRONMENT BY A FEW SHOTS MAY WELL NOT HAVE INFLUENCED THE NATIVES APPRECIABLY BY THE TIME THE RESURVEY CAN BE MADE. ON THE OTHER HAND, IF THE BEGINNING CHANGES ARE OBSERVED (BASED ON MEMORY OF THE ORIGINAL LOST DATA), IT MAY TURN OUT TO BE MOST IMPORTANT THAT THEY BE DETECTED AND EVALUATED.

(PARA) CONSEQUENTLY, WE REQUEST THAT PLANS BE MADE TO DO THE JOB IN THE MANNER SUGGESTED IN YOUR MESSAGE. THE TEAM, CONSISTING OF DR. ROBERT A. CONARD, DR. JAMES S. ROBERTSON, AND MR. DANIEL V. FORTER, CAN BE AT ENVIKTOK WITH THEIR EQUIPMENT AS EARLY AS MAY 7 PROVIDED THAT TRANSPORTATION REQUIREMENTS CAN BE MET. HOWEVER, MUST KNOW SOONEST INFORMATION CONCERNING THE AVAILABLE POWER
