VIVORS ACT TO PROVIDE FOR ADEQUATE MEDICAL CARE AND OTHER BENEFITS TO THE PEOPLE OF RONGELAP AND UTIRIK ATOLLS EXPOSED TO THE MARCH 1954 H-BOMB FALLOUT AND TO PROVIDE FOR MEDICAL CARE AND OTHER BENEFITS TO DESCENDANTS OF EXPOSED PERSONS AND CONTROL PERSONS HOW LIVING ON THESE ATOLLS. CAN YOU SUPPLY COPY OF BILL SOONEST. WE DO NOT SEEM TO HAVE COPIES OF ANY PROPOSED SENATE BILLS BELOW THE NUMBER OF 126 IN THE COM MATERIAL SENT US THUS FAR. SHOULD THIS BILL PASS THE HOUSE AND IF CONTAINS ANY REFERENCE TO BINDING ACTION ON ANY FEDERAL AGENCY. I. E. DEPARTMENT OF ENERGY WE WOULD NEED TO HAVE IT CONSIDERED AT FEDERAL LEVEL.
