BALOS NOTED THAT BECAUSE OF FALLCUT FROM BIKIMI TESTS,

THE PEOPLE OF RONGELAP AND UTERIK WERE STILL AFFECTED AFTER

KNOWS WHAT WILL HAPPEN IN THE FUTURE."

I FIRST EXPLAINED THE QUALITATIVE DIFFERENCE BETWEEN THE 1954 EXPERIENCE OF THE UTERIK/RONGELAP PEOPLE AND THE LOW LEVEL CHRONIC EXPOSURE INCIDENT TO RESETTLING AN ISLAND OR ATOLL WITH SLIGHTLY ELEVATED BACKGROUND.

I FURTHER EMPHASIZED THE EXCEPTIONALLY LOW RADIATION LEVELS HERE ON ENEWETAK (ON THE ISLANDS DESIGNATED FOR EARLY RESETTLEMENT).

EXAMINATION AND MEDICAL RESPONSIBILITY. I TOLD HIM QUITE
BLUNTLY THAT WE DO NOT EXPECT ANY RADIATION-INDUCED MEDICAL

THEM BECAUSE OF THEIR CONTRIBUTION TO THE U.S.

AS AN INDIVIDUAL, I ACKNOWLEDGED THESE THINGS BUT POINTED OUT

THAT IT TAKES LEGISLATIVE AUTHORITY (AND FUNDS) TO DO WHAT

HE ASKS; VIZ "BEAR THE RESPONSIBILITY IF SOMEONE BECOMES

ILL..." NEANWHILE (THE DISTRICT ADMINISTRATOR AGREED), HEALTH

CARE OF THE ENEWETAK PEOPLE IS A TRUST TERRITORY RESPONSIBILITY.

I THEN TURNED TO THE MATTER OF PERIODIC "MEDICAL" EXAMINATIONS AND EXPLAINED THE DIFFERENCE BETWEEN EXAMINATION FOR MEDICAL INDICATIONS AND BIO-ASSAY AS A TECHNIQUE OF ENVIRONMENTAL SURVEILLANCE. THIS IS A VERY DIFFICULT CONCEPTUAL DIFFERENCE, BUT I TRULY BELIEVE THAT BALOS UNDERSTOOD IT; AT LEAST HE SAID SO.

OUR CONVERSATION ENDED CORDIALLY, AS HAS EVERY CONVERSATION OVER 5 YEARS. I MAY HAVE IMPROVED HIS UNDERSTANDING, BUT DON'T HOLD YOUR BREATH FOR ANY SORT OF RETRACTION OR CLARIFICATION OF HIS PRESS STATEMENT.
