

In August 1964 the United States Congress appropriated the sum of \$950,000 which, after legal expenses, was paid to the affected inhabitants of Rongelap Atoll. Each of the 82 exposed individuals or his heirs received approximately \$10,000 as a lump sum. The 357 people of Utirik, who had received a lesser degree of exposure, were not compensated.

Since the 1964 payment, thyroid abnormalities have been appearing in the exposed Rongelapese and 25 operations for thyroid removal have taken place. Leukemia also appeared in a 19-year-old boy who had been exposed as a one-year-old infant. This young man died in 1974 in the National Cancer Institute, Clinical Center, Bethesda, Maryland, while being treated for acute myelogenous leukemia. Twenty-nine of the original exposed Rongelap population of 84 have developed thyroid abnormalities.

Additionally, in the past two years six cases of thyroid abnormalities have appeared in the Utirik exposed group.

In 1972 the Congress of Micronesia created a Special Joint Committee Concerning Rongelap and Utirik Atoll. In May 1975 the Chairman of the Special Joint Committee and one of the Committee members met in Washington, D.C., with United States Senators and Congressmen about a request for additional compensation to the exposed persons or their survivors. This included an "inconvenience payment" of \$1,000 each to 157 people of Utirik or their survivors, payments to the mother and father of the Marshallese boy who died of acute leukemia in 1974 and payment of \$25,000 each per person per thyroid operation, past and future.

A proposed bill for additional compensation was prepared by the Department of the Interior and has been submitted to the Office of Management and Budget for clearance and transmittal to the United States Congress.

Preliminary conferences with Congressional members on the part of Interior officials and Congress of Micronesia members have indicated that the appropriate United States Congress Committees will give a sympathetic hearing to this proposal.
