I am writing you in regard to the purchase of clothing for the Rongelap people who will be coming to the United States. I thought it might be useful for your wives to have information on height and weight on the girls, in order to help them in these purchases. is a 46 year old woman, height 4'11", weight 85-1/2 lbs.; a 13 year old girl, height 4'5-1/2", weight 59 lbs.; a 13 year old girl, height 4'11", weight 80 lbs.; a 13 year old girl, height 5'2-1/2", weight 100 lbs.; and a 20 year old girl, height 4'11", weight 166 lbs. I hope that the necessary clothing can be picked up at Macy's. They will certainly need a warm sweater each, and I am not sure that I can get these there. If not, could you contact by radio telephone Mr. Rasmussen at the AEC office in Honolulu and ask him to purchase sweaters for each of them. Give him their sizes. Since it is planned that the group will leave Honolulu for New York the day following their arrival, there would be insufficient time after they arrive in Honolulu. I hope that you have been able to get the patients and Billiet from Rongelap by now. Would appreciate hearing from you in regard to these plans. I am making arrangements to buy the commercial plane tickets from Honolulu to New York and make reservations. Have also arranged to admit them to the hospital here and for possible surgery.
