Gentlemen:

The purpose of this letter is to inform the members of the Congress of Micronesia regarding recent developments on the work of the Special Joint Committee Concerning Rongelap and Utirik Atolls.

The attached document summarizes the background and current status of legislation drafted to provide additional compensation for the affected Marshallese. What is presented is an excerpt from U.S. Ambassador Sherer's remarks addressed to the 43rd Session of the United Nations Trusteeship Council.

While we are somewhat concerned that it has taken over one year for the legislation to be drawn up.

## (Mr. Sherer, United States)

In August 1964 the United States Congress appropriated the sum of \$950,000 which, after legal expenses, was paid to the affected inhabitants of Rongelap Atoll. Each of the 82 exposed individuals or his heirs received approximately \$10,000 as a lump sum. The 157 people of Utirik, who had received a lesser degree of exposure, were not compensated.

Since the 1964 payment, thyroid abnormalities have been appearing in the exposed Rongelapese and 25 operations for thyroid removal have taken place. Leukemia also appeared in a 19-year-old boy who had been exposed as a one-year-old infant. This young man died in 1974 in the National Cancer Institute, Clinical Center, Bethesda, Maryland, while being treated for acute myelongenous leukemia. Twenty-nine of the original exposed Rongelap population of 64 have developed thyroid abnormalities.

Additionally, in the past two years six cases of thyroid abnormalities have appeared in the Utirik exposed group.

In 1972 the Congress of Micronesia created a Special Joint Committee Concerning Rongolap and Utirik Atoll. In May 1975 the Chairman of the Special Joint Committee and one of the Committee members met in Washington, D.C., with United States Constors and Congressmen about a request for additional compensation to the exposed persons or their survivors. This included an "inconvenience payment" of \$1,000 each to 157 people of Utirik or their survivors, payments to the mother and father of the Marchallese boy who died of scute leukemia in 1974 and payment of \$25,000 each per person per thyroid operation, past and future.

A proposed bill for additional compensation was prepared by the Depositrent of the Interior and has been submitted to the Office of Management and Budget for electronce and transmittal to the United States Congress.

Preliminary conferences with Congressional members on the part of Literior officials and Congress of Micronesia members have indicated that the appropriate United States Congress Committees will give a sympathetic hearing to this proposal.
