Dear Captain Turney:

I am writing to express my appreciation for the cooperation of your laboratory in making available personnel and equipment to perform the highly important follow-up medical examinations on the Marshallese inhabitants who were exposed to radiation during the recent test series in the Pacific. The Atomic Energy Commission considers this mission to be of utmost importance, not only to the health and welfare of the Marshallese inhabitants for whom we now have a particular responsibility but to the future availability and use of the Marshall Islands area for the conduct of tests of nuclear and thermonuclear devices.

We feel we are most fortunate in having Dr. V. P. Bond as the leader of the first of successive teams to conduct follow-up examinations, and we are grateful to the Navy for making his services available.

In organizing this program for follow-up medical examinations the Atomic Energy Commission has been careful to maintain timely liaison with the Chief of Naval Operations, the Department of State, and the Department of the Interior. Arrangements at this end are now virtually completed, and we understand from the office of the Chief of Naval Operations that appropriate priorities and support for this mission have been arranged. We took the precaution of making arrangements with the Chief of Naval Operations in order to assure the smooth, orderly, and uninterrupted transport of the teams to and from the Marshall Islands area. It would be most unfortunate, and potentially embarrassing to the United States, and possibly
