DRAFT INFORMATION PLAN FOR OPERATION HARDTACK

Attached for your concurrence and/or comment is the draft Information Plan for Operation Hardtack. This is the second draft to receive your review and is identical with the first except for the following reflections of the comments received on the first draft:

Page 2, Paragraph 4, language added to enable DMA subsequently to develop criteria for selection of shots to be announced rather than to delay Commission consideration of the paper until the criteria are worked out; and noting IGY interest in detonations detectable at considerable distances.

Page 5, Paragraph 12b., changed to conform with B.M. suggestion regarding independence of Public Health Service with respect to public release of fallout readings.

Page 6, Paragraph 14b., the word "firing" inserted after "JTF" in second line, to make clear what the criteria relate to.

Page 6, Paragraph 15 rewritten to emphasize that statements beyond announcement of certain of the detonations would occur only when dictated by unusual circumstances and would be subject to top AEC and DOD review.
