SUBJECT: TTPI -UTIRIK AND RONGELAP RADIATION VICTIMS

1. WE FIND IT DIFFICULT TO RESPOND TO REF D (AND TO REFS A, B, AND C) IN ABSENCE OF YOUR RESPONSE TO REF E REQUESTING FURTHER INFORMATION. HOWEVER, OUR INITIAL REACTION IS AS FOLLOWS.

2. EMBASSY HAS NO RPT NO INFORMATION ON GOJ TREATMENT AND COMPENSATION OF RADIATION VICTIMS AND THEREFORE CANNOT PROVIDE BRIEFING.

3. WE ARE PREPARED TO ADVISE MIN OF HEALTH OF GROUP'S ARRIVAL AND INTERESTS BUT THEREAFTER ANY ASSISTANCE RENDERED OR INFORMATION PROVIDED WOULD BE STRICTLY AT DISCRETION OF GOJ. FYI WE BELIEVE IT WOULD BE MISTAKE FOR EMBASSY AND USG TO GET BETWEEN MICRONESIAN DELEGATION AND GOJ ON ISSUE AS EMOTIONAL AND POTENTIALLY DISRUPTIVE AS THIS. END FYI.

4. WE ARE ALERTING ABCC REGARDING POSSIBILITY GROUP'S VISIT THERE.

5. EMBASSY PLEASSED TO MAKE RESERVATIONS AT HOTEL NEW JAPAN BUT SUGGEST DELEGATION AVAIL ITSELF OF NO PUB. OF ENERGY TRANSPORTATION READILY AVAILABLE AT AIRPORT.
