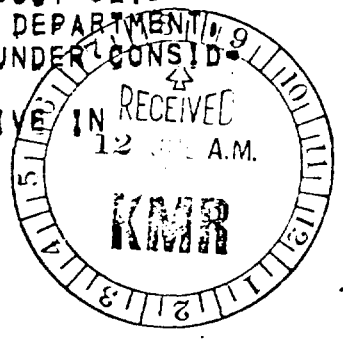

 2. INTERIOR HAS REQUESTED THAT A TPTI REPRESENTATIVE BE PRESENT
 AT THESE HEARINGS AND PREPARED TO ANSWER QUESTIONS RELATED TO
 CIVIL ADMINISTRATION. OMSN HAS REQUESTED THAT STATUS LNO (OR
 HIS DEPUTY) BE AVAILABLE TO FIELD QUESTIONS ON POLITICAL STATUS

 A. \$20 MILLION FOR EHEWR AK CLAN-UP WAS REQUESTED BY DOD
 IN ITS FY77 MILCON SUBMISSION TO CONGRESS. THE SENATE AND HOUSE
 HAVE APPROVED THIS APPROPRIATION, AND WE ARE HOPEFUL THAT FUNDS
 TO START THE PROJECT WILL BE MADE AVAILABLE IN OCT 76.
 B. NEW RADIOLOGICAL SURVEY OF BIKINI BY ERDA IS CONTINGENT
 UPON FUNDING OF LOGISTIC SUPPORT, ESTIMATED TO COST ABOUT \$2.5
 MILLION. SINCE FUNDS HAVE NOT BEEN PROGRAMMED BY ANY DEPARTMENT
 OFFICE OF MANAGEMENT AND BUDGET HO/; HAS THIS MATTER UNDER CONSID-
 ERATION.
