MEMORANDUM FOR THE RECORD

I understand that the President wrote to Congressman Cole today that the AEC film IVY could be shown to all congressional personnel, but should not be shown to Washington correspondents, because it was intended later to release it to all public information media.

At the OCB meeting today, Deputy Secretary Kyes raised a question as to the advisability of such a public release. Admiral Strauss was going to talk with Mr. Kyes about it.

It seems to me that this matter should be taken up at the Council Meeting, along with the civil defense item.
