
7. Legislation for Reimbursement of Rongelapese -

9. Design Study on Follow-on PWR -

The Commission agreed to request Fiscal 1963 supplemental funds. The Chairman said it should be clearly indicated that the scope of the study may be broadened. Dr. Haworth is to discuss the matter with a Westinghouse official. (Pittman - McCarthy)

10. Fast Oxide Breeder Experiment -

The Commission agreed to request Fiscal 1963 supplemental funds for the experiment. Appropriate reports on both projects are to be submitted to the Commission. (Pittman - McCarthy)

11. Letter to Mr. Bundy re Expanded Pacific Danger Zone -

The Chairman said he would sign the letter. (Henderson)

12. Disposal of Los Alamos Community -

Mr. Graham said he was sending the Commissioners a memorandum on this matter today.

13. Chairman's Meeting with Representative Cannon to Discuss Weapons Test Program -
