- (5) 0215M - J-3 Office closed on NAN. LCDR Smure remained in Station 70.
- (6) 0325M - Last boat departed for USS BOXER with last evacuees - approximately twenty (20) hours ahead of original schedule.
- (7) 0440M - Today became S-1 due to weather.

- a. The primary time for NUTEG was cancelled and the shot was fired at 0920M. (ROS)


